

## Palladium Spirits Fund

Palladium Spirits Fund is a collaboration between RHT DigiCapital Pte Ltd (Fund Manager) and Midas Spirits Pte. Ltd. (Fund Advisor), and whose objective is to achieve medium to long-term capital appreciation for investors through investments into whisky casks and/or bottles.

### Key Strategies

1. Cask Opportunities – Gain rare access to new and established Japanese and Scottish distilleries, to purchase casks of limited supplies, with the potential for appreciation.
2. Bottle Opportunities – Gain rare access to bottles trading at good valuations, or purchased at launches due to valued relationship.
3. Potential value enhancement – For casks that will be bottled, the Fund may seek to enhance the value of these limited releases by creating ‘series’ bottling in collaboration with established whisky connoisseurs (for the whisky selection) and established artists (for the artwork and labels) to create unique ‘Whisky Art Pieces’.

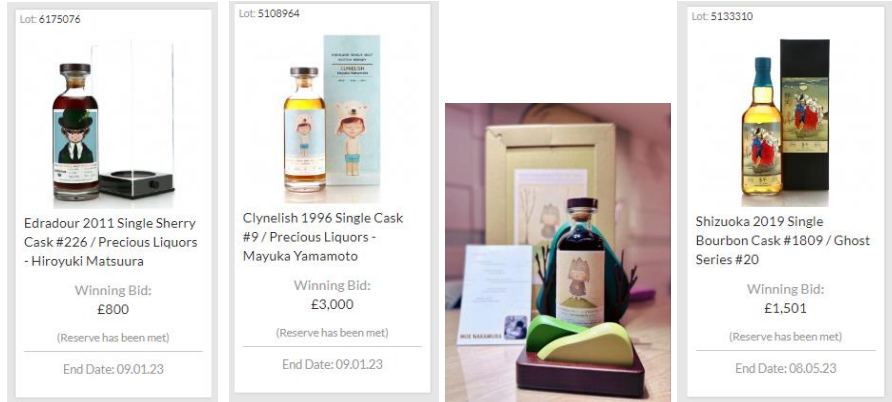

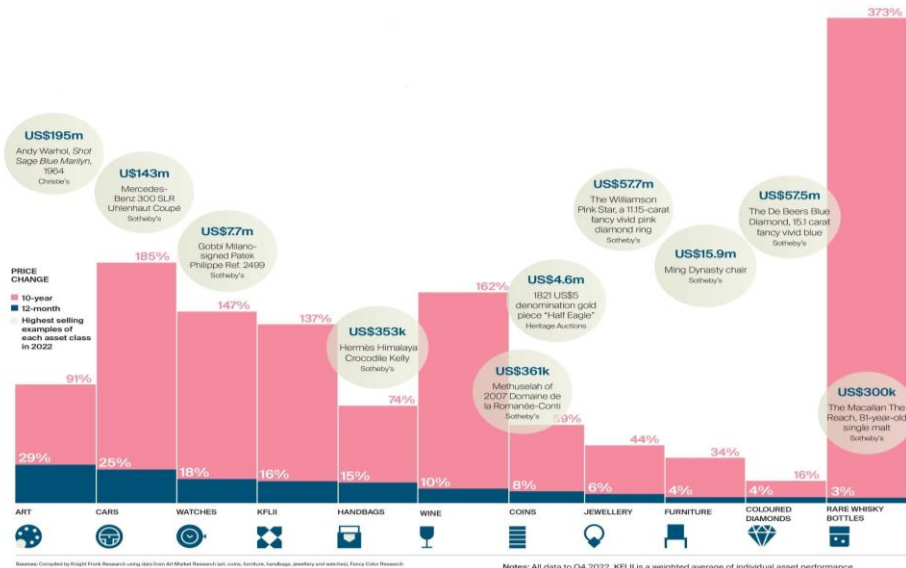

Whisky as an Outperforming Asset Class



The Knight Frank Luxury Investment Index (KFLII), which tracks the value of 10 investments of passion, rose by a healthy 16% during 2022, comfortably beating inflation and outperforming the majority of mainstream investment classes.

Whisky, in particular, remained KFLII's 10-year leader by a good margin (+373%).
